REQUIREMENTS FOR FILING

- Copy of applicant's valid Westchester County Master Plumbers License
- List of type of materials to be used on job (XHCI, PVC, etc) See Chapter 100-18 of Town Code for material regulations (more restrictive than NYS Code) –UNDERGROUND SANITARY SEWER LINES/PIPING SHALL BE BELL AND SPIGOT XHCI, SERVICE WEIGHT CAST IRON
- Fees for new work (Check/credit card/money order) \$150 for first \$1,000 estimated cost plus \$15 per \$1,000 thereafter (Rounded up)
- Fees for work started without a permit are \$300 for first \$1,000 estimated cost, plus \$30 per \$1,000 thereafter (Rounded up)
- Specifications on boilers, hot water heater and any other equipment to be installed

BOILER INSTALLATIONS

- RESIDENTIAL** - Copy of Manual J - Section R403.7 of the 2020 IECC is a mandatory section requiring heating and cooling equipment be sized in accordance with ACCA Manual S based on building loads calculated in accordance with ACCA Manual J
- COMMERCIAL** - Copy of Heating/Cooling Load Calculations - Section C403.1.1 of the 2020 IECC is mandatory and must be in accordance with ASHRAE/ACCA Standard 183
