

**TOWN OF GREENBURGH ONE SEASON PILOT PROGRAM**  
**APPLICATION FOR A SNOW PARKING HARDSHIP EXEMPTION**

The Town Board, in concert with the Police Department and the Department of Public Works, is piloting another season (December 1, 2021 – March 15, 2022) snow parking hardship exemption issued by the Chief of Police for public streets in the unincorporated area of the Town of Greenburgh other than those streets listed in Section 460-20.1 (East Hartsdale Avenue and metered parking spaces on Columbia Avenue), which have snow parking requirements specific to that area. Unless a hardship exemption is granted, the issued permit is properly displayed on the vehicle and the exemption is still in force, the regulations in the Code of the Town of Greenburgh Section 460-20, “Snow Parking,” shall continue to apply.

**PLEASE TAKE NOTE:** The granting of a “hardship exemption” is not automatic and you must qualify for the exemption before a revokable Overnight Parking Permit is granted. This application, the supporting materials, and data available will be carefully reviewed by the Greenburgh Police Department before a decision will be reached. Display of a forged or revoked permit will be prosecuted.

**CAUTION:** *Applicants are reminded that they must comply with all statutes, laws, regulations and rules for the registration, inspection and operation of motor vehicles in this state, including NYS Vehicle and Traffic Law Section 250(1) providing a 30-day time frame for registration of vehicles by individuals who become NYS residents and Section 401(3) establishing a 10-day requirement for vehicle owners to provide change of address notification to the Department of Motor Vehicles.*

## **TOWN OF GREENBURGH DECEMBER 1, 2021– MARCH 15, 2022 SNOW PARKING HARDSHIP EXEMPTION PILOT PROGRAM INSTRUCTIONS**

1. The Applicant must be the owner (or lessee)/operator of the vehicle for which the exemption is requested. Complete the entire application leaving NO ANSWERS BLANK. Applications that are incomplete, or missing documentation or the application fee, are subject to rejection and will not be processed. Return the application and supporting materials by mail or in person to the Greenburgh Police Department, 188 Tarrytown Road (P.O. White Plains, NY 10607), Attn: Snow Parking Exemption, where it will be circulated for review and processing. Include with your application:
  - a. A copy of a valid vehicle registration for the vehicle (not a photo of the vehicle's window-affixed sticker) that needs to be parked on the street between 1:00 a.m. and 6:00 a.m.;
  - b. A copy of your valid driver's license; the Town reserves to right to request additional or alternate documentation if needed to render a determination of eligibility; and
  - c. A non-refundable application fee of \$25.00. This is not a parking fee. It is collected to offset the expenses associated with the review and processing of this application. Make your check or money order payable to: "Town of Greenburgh." Cash accepted in person only. Do not mail cash.
2. A vehicle owner (lessee)/operator may use one application to apply for more than one (1) vehicle at the same address for which there is inadequate off-street parking. If you are applying for more than one vehicle at the same address, the fee for the first vehicle is \$25.00, and \$25.00 for each additional vehicle.
3. Any outstanding/unpaid parking fines and penalties must be paid in full prior to submitting the application. If any unpaid fines are under judicial review, please indicate so on your application.
4. At a minimum, the application will be reviewed by the Town of Greenburgh Police checking validity of the driver's license, vehicle registration, outstanding fines and inspecting the property regarding the adequacy of off-street parking / need for the hardship exemption.
5. The Applicant and the property owner (if different) must certify and sign the application where required. If you are a resident of an apartment or condominium complex, you must obtain and provide a signed letter (with a current date) from the management company confirming there is no parking available, either paid or free, for your vehicle. If you are a student, part-time resident, temporary assignment employee or other, needing the exemption, please attach appropriate documents as evidence indicating this status.
6. You must adhere to all parking rules and regulations. Remember that there is no parking on any street in the unincorporated area of the Town of Greenburgh between the hours of 1:00 a.m. and 6:00 a.m., except as provided in the Code of the Town of Greenburgh Section 460-20.1, without having first obtained a Snow Parking Hardship Exemption. It is your responsibility to ensure that you park your vehicle on the street lawfully.
7. The Snow Parking Hardship Exemption is not granted automatically upon submission of an application. The Hardship Exemption is not a right, but rather a privilege. A decision is reached on each application individually after a complete review of the application, including confirmation of the validity of your motor vehicle documentation, an inspection of the property in question, etc.

**ATTENTION: THE VEHICLE OWNER IS RESPONSIBLE FOR RESPONDING TO ALL SUMMONSES ISSUED. Do not ignore a summons issued to your vehicle. If you receive a summons for any reason, such as parking in an improper area, parking on the wrong side of the street, or any other violation, follow the instructions printed on the ticket. If it is solely a snow parking related summons and you had a valid Overnight Parking Permit properly displayed, also follow the directions in 7 above.**

8. Snow Parking Hardship Exemption (Overnight Parking Permits) are specific to the vehicles having the registration numbers and address (with inadequate off-street parking) indicated on your application ONLY. They are NOT transferable.
9. The Overnight Parking Permit must be prominently displayed hanging from the rear view mirror of the recipient's vehicle while parked overnight.

**\*\*It is the responsibility of the recipient to remove the permit from the rear view mirror prior to driving in accordance with NYS Vehicle and Traffic Laws\*\***



**ATTENTION: The Town and its agents are not responsible for damage caused to vehicles that result from the lawful operation of snow removal equipment. Ensure vehicles are off the street when a snow emergency is declared.**
